- John Crotteau indicated Paula feels she has gotten all the requests we will probably be getting for donations to the raffle due to (1) COVID--donators have been modifying their policies during COVID for donations to 501C3 causes; and (2) they feel our cause may not be as valuable a cause to move people to donate, that it's not something that pulls at one's heartstrings like other causes do.

Fast CAT: The Fast CAT tests were held on June 19 and 20, and we had Fun Runs on Friday evening after setting up, and also offered them on Saturday. President Strassburger reported the weekend went very well, the community really supported the events, exhibitors were very happy with the site, especially with the site located on a lake and that the lane was flat. Parking worked out OK. We were not aware until Friday afternoon that Tina was not going to be there for the weekend, but Kim who filled in for her did a great job and was very willing to show everyone all the jobs. Rose reported on the delays on Tina's part to get reports back to her so we could submit the necessary payment for the AKC recording fees, and as of yet, we have not received copies of the reports and scoresheets that Tina promised to get to us back on June 28. Rose also reported we were not informed that Kim's runs would be comped and she only discovered this after going through the entries and checks submitted and finding that there was no payment for Kim's three dogs who had a total of 12 runs. Those runs were included in Don's totals so not only were we short by \$240 for those runs, we still had to pay \$3.50 to AKC, \$5.00 to Don, and \$1.50 to Tina, for each run.
